



PRICING POLICY EFFECTIVE 1ST JANUARY 2019

MEMBERSHIPS & DAY PASSES

Badminton Court rental	AED 65 /court/ hour

Requirements:

1. Public users must be at least 18 years old and above.
2. Payment must be made to the administrator of Hamdan Sports Complex before using the swimming pools, gym and sauna facilities. Payments made are non-refundable.
3. A medical certificate (from the General Practice doctor in the U.A.E.) must be presented to the Hamdan Sports Complex administration before using the swimming pools. The certificate must be updated yearly.
 - All individuals with serious medical conditions should be accompanied in the water with another individual knowledgeable of their condition
4. Swimmer must comply to all the terms and conditions, and rules and regulations of the complex

Booking Policy for Pool Hiring

For Training

Booking Policy:

1. All bookings must be made in writing to the Pool Supervisor of Hamdan Sports Complex
2. The Pool Supervisor may exercise his/her discretion to increase/decrease the number of pools/lanes to be allocated, based on the demand of the general public and training needs of the hirer.
3. Bookings are allowed up to twelve months in advance only
4. For short term rentals, full payment is required at least 1 day prior
5. For long term rentals, full payment is required within 15 days after monthly invoice is issued
6. Hirer must comply to all the terms and conditions, and rules and regulations of the complex

Cancellation Policy:

1. For cancellation and changes, at least 1 day notice in writing must be given prior to the rental date to cancel or change
2. For cancellation made within the same day, full charges apply

For Competitions:

Booking Policy:

1. All bookings must be made in writing to the Pool Supervisor of Hamdan Sports Complex
2. The Pool Supervisor may exercise his/her discretion to increase/decrease the number of pools/lanes to be allocated, based on the demand of the general public and event needs of the hirer.
3. Bookings are allowed up to twelve months in advance only
4. 50% Deposit is required 1 month before event date, and the balance 3 days before event date
5. Hirer must comply to all the terms and conditions, and rules and regulations of the complex



Cancellation Policy:

1. For cancellation and changes, at least 7 days notice in writing must be given prior to the rental date to cancel or change
2. For cancellation made 7 days or less prior to event date, full charges apply
3. Deposits are non-refundable
